The name of the dog and all the details as recorded with the Kennel Club must be given on this entry form. If an error is made the dog may be disqualified by the General Committee of the Kennel Club. All dogs must be REGISTERED at the Kennel Club in the name of the competitor. If the registration or transfer of ownership has not been confirmed it must be applied for before the closing date of entries. In case of dispute proof of postage of such applications may be required by the Kennel Club. Dogs under 18 months of age on the first day of the Show cannot be entered for competition. On no account will entries be accepted without fees. If a dog is in the process of Registration or Transfer at the time entry is made, add the letters NAF or TAF as appropriate after it's name. Please put classes in numerical order and USE BLOCK CAPITALS throughout when completing this entry form. PLEASE CHECK ALL DETAILS BEFORE POSTING. \* The KC Authority to Compete number for dogs resident outside the UK must be stated or the entry will be returned.
